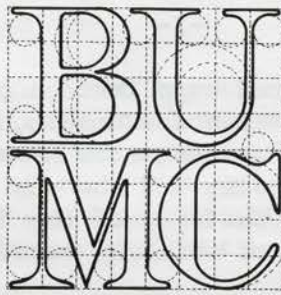

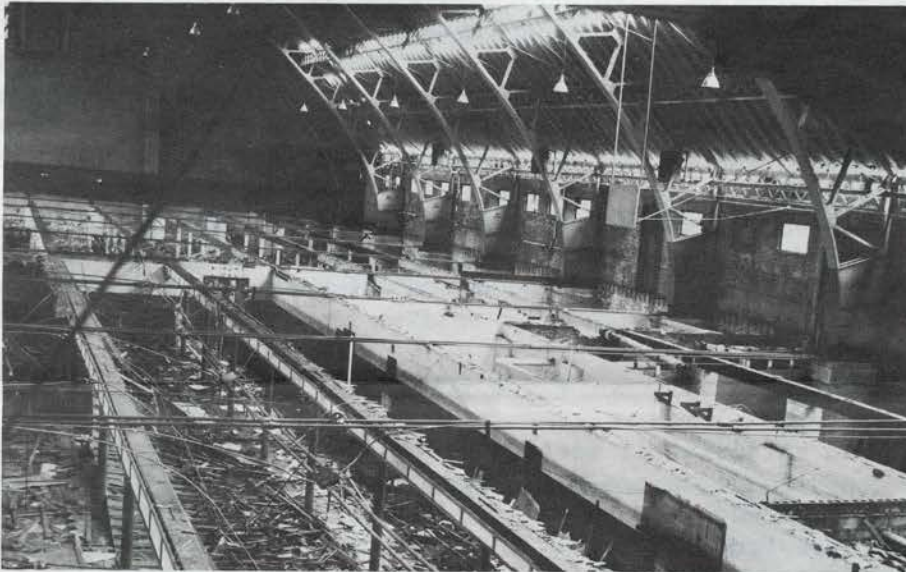

Dr. Richard H. Egdahl has been appointed new Chief of Surgery as of July 1, 1964, when Dr. Reginald H. Smithwick retires from the post he has filled with distinction and to which he has brought international recognition to himself and to BUMC. Dr. Egdahl, Professor of Surgery at the Medical College of Virginia, holds degrees from Dartmouth College, Harvard Medical School, and the University of Minnesota (Ph.D.) He has gained wide recognition in the fields of organ transplantation and neuroendocrinology, and will bring to the BUMC Department of Surgery a number of associates in this area, and together the team will be in charge of the artificial kidney program.
